



# CONDITIONS OF ENTRY: SHOWING

All entries booked and not taken must be paid for.

No Horse or Pony under 4yrs is eligible to compete in Ridden Classes

A fall of animal or rider whilst mounted in any class will result in disqualification and they **MUST** leave the ring dismounted.

Stallions/Colts may not be lead by any competitors who have not attained their 16th Birthday.

Stallions may not be Ridden by any competitors that have not attained their 14th Birthday.

It is highly recommended that Stallions should wear a stallion disc and that it is the responsibility of the competitor to ensure that their Stallion is clearly identified as such by other competitors.

Correct Riding Dress to be worn. It is mandatory for all competitors to wear a protective helmet that complies with the highest current safety standard. Anyone seen to be mounted without a safety hat will be asked to leave the premises immediately.

We strongly advice that all entrants should ensure that they, their horses/ponies are fully covered for third party insurance.

No responsibility will be accepted by the promoter/organiser for any accident,injury,damage or loss whether to competitors,spectator, servant,any animal,vehicle or their property however caused or in conjunction with or arising from the show.

It shall be condition of entry that each entrant agrees to indemnify the promoters/organisers against any legal action arising there from.

The promoters/organisers reserve the right to cancel any class with insufficient entries.
